A local law Amendment to Local Law No. 3 of 1979 - Sewer Ordinance No. 152

Local Law No. 3 of 1979, Section 2, amending Sewer Ordinance No. 152, is hereby amended to delete the two designations "(1)" and to add an opening paragraph, and shall read as follows:

2. That said ordinance be amended by repeal of the Section 5, subdivision (c) (7) thereof and the addition of a new Section 5, subdivision (c) (7) which shall read as follows:

(7) Any waters or wastes containing a toxic or poisonous substance in sufficient quantity to injure or interfere with any sewage treatment process, or which constitute a hazard to humans or animals, or create any hazard in the receiving waters of the sewage treatment plant.

Any water or wastewater shall be within the following limits at the point of entry into the municipal collection system.
