Local Law No. 1 of 1978 (Sidewalk Ordinance), Section SIXTH (G), as amended by Local Law No. 4 of 1978, is hereby further amended to read as follows:

G. The provisions of this Subdivision will be applicable for sidewalk installations that will be done between May 1 and October 1, and at other times at the discretion of the Village Superintendent depending on the suitability of the weather.

Local Law No. 1 of 1978 (Sidewalk Ordinance), Section TENTH, is hereby amended by the addition of the following paragraph:

Nothing contained in this Local Law shall relieve any owner of real property from his responsibility to keep the public sidewalks on his property at all times in good repair, and the property owner shall at all times be solely liable for any injury to persons or property resulting from his failure to keep such sidewalks in good repair.

This Local Law shall take effect immediately upon filing with the Secretary of State.
