The Traffic Regulation, Local Law No. 1 of 1977, of the Village of Watkins Glen, is hereby amended by the addition to Article VIII, Section 80, of the following additional stop intersections, with stop sign to be erected at the entrance thereto as indicated:

<u>Intersection of</u>	<u>With/Stop Sign on</u>	<u>Entrance</u>
Route 409 (Steuben St.)	Madison Avenue	North and South
Route 414 (Fourth St.)	Clute Park exits	North and South
Route 414 (Fourth St.)	Cargill Salt Company Driveway	North
Route 14 (Franklin St.)	Acme Plaza driveway	East




