Section 1. Legislative intent. The intent of the Board of Trustees the Village of Watkins Glen is to implement section 1402(3) of the Reproperty Tax Law providing for the voluntary termination of the Village status as an assessing unit, as provided in the Village Law and the Reproperty Tax Law. It is also the intent of this local law to abolish the position of Assessor and to terminate any and all responsibility as provided by law for the review of the assessments of real property located within the Village of Watkins Glen.

- Section 2. On or after the effective date of this local law, the Village of Watkins Glen shall cease to be an assessing unit.
- Section 3. The position of Assessor in the Village of Watkins Glen hereby abolished.
- Section 4. The Board of Assessment Review in the village of Watkir Glen is hereby abolished.
- Section 5. On or after the effective date of this local law, taxes is the Village of Watkins Glen shall be levied on a copy of the applicable particle of the assessment rolls of the Towns of Dix and Reading with the taxable status date of such Towns controlling for Village purposes.
- Section 6. Within five days of the effective date of this local law the Board of Trustees of the Village of Watkins Glen shall file a copy c such local law with the Clerks and Assessors or Board of Assessors of the Towns of Dix and Reading and with the State Board of Equalization ar Assessment.
- Section 7. This local law shall take effect immediately upon mailing t the Secretary of State, provided, however, that such local law is subject t a permissive referendum and the Village Clerk shall forthwith proceed t notice such fact and conduct such referendum if required by petition.
