Local Law No. 4 of the year 2003

A LOCAL LAW AUTHORIZING THE ESTABLISHMENT OR EXTENSION OF BUSINESS IMPROVEMENT DISTRICTS PURSUANT TO GENERAL MUNICIPAL LAW ARTICLE 19-A.

Be it enacted by the VILLAGE BOARD of the

Village of WATKINS GLEN as follows:

## SECTION 1.

This Local Law, pursuant to the General Municipal Law, Section 980-b of Article 19-A-BUSINESS IMPROVEMENT DISTRICTS, provides that the provisions of Article 19-A shall be applicable to the establishment or extension of Business Improvement Districts in the Village of Watkins Glen, New York.

## SECTION 2.

The invalidity of any word, section, clause, paragraph, sentence, part or provision of this Local Law shall not affect the validity of any other part of this Local Law which can be given effect without such invalid part or parts.

## SECTION 3.

Pursuant to Section 9-900, subdivision 2 of the Village Law of the State of New York, the Village Clerk is hereby authorized and directed to post and publish a notice within ten (10) days of the adoption of this Local Law, which notice shall set forth the date of the adoption of this Local Law and contain an abstract of this Local Law concisely stating the purpose and effect thereof, and indicating that such Local Law is subject to a Permissive Referendum.

## SECTION 4.

Following the passage as the result of such Permissive Referendum as may be called for by the resident electors of the Village, or in the absence of such Permissive Referendum, upon

the expiration of the time period within which a Permissive Referendum may be called for, this Local Law shall thereafter take effect immediately upon its filing in the Office of the Secretary of State of New York as provided in Section 27 of the Municipal Home Rule Law.

5. (City local law concerning Charter revision proposed by petition.)

I hereby certify that the local law annexed hereto, designated as local law No. \_\_\_\_\_ of 20\_\_\_\_ of the City of \_\_\_\_\_ having been submitted to referendum pursuant to the provisions of section (36)(37) of the Municipal Home Rule Law, and having received the affirmative vote of a majority of the qualified electors of such city voting thereon at the (special)(general) election held on \_\_\_\_\_ 20\_\_\_\_, became operative.

6. (County local law concerning adoption of Charter.)


