PLEDGE OF ALLEGIANCE

Resolution – Sewer Department Reserves Transfer

Trustee Anthony Fraboni made the motion to approve the following resolution to transfer \$32,917 to the sewer reserve account per the consent order. Trustee Laurie DeNardo seconded the motion. The Board then voted on the motion and all were in favor. Motion Carried.

WHEREAS, the Village of Watkins Glen is under a consent order to create and maintain a short-lived asset reserve account as part of our USDA grant; and

WHEREAS, the Village of Watkins Glen had purposed to put \$32,917 in a reserve account for fiscal year 2019-2020 to comply with the consent order;

BE IT RESOLVED, that the Village of Watkins Glen Treasurer be authorized to increase account GG.0231.100 and decrease account GG0201.000 by \$32,917.

Website Design Proposal

Trustee Nan Woodworth made the motion to award the Villages new website design to DSD Web Works for a onetime fee of \$500 and then \$365/month. Trustee Laurie DeNardo seconded the motion. The Board then voted on the motion and all were in favor. Motion Carried.

Resolution - Demolition of Waste Water Treatment Plant

Trustee Laurie DeNardo made the motion to approve the following resolution to authorize the application for grant funds through the 2019 consolidated funding application to deconstruct the existing Village waste water treatment plant located on the shore of Seneca Lake. Deputy Mayor Louie Perazzini seconded the motion. The Board then voted on the motion and all were in favor. Motion Carried.

WHEREAS: The Village of Watkins Glen is committed to securing funding to further the priority projects identified by the Village's Local Waterfront Revitalization Plan (LWRP), Comprehensive Plan, and Downtown Redevelopment Initiative Plan; and

WHEREAS: The new Regional WWTP plant is nearing completion and the former WWTP will need to be decommissioned and demolished.

WHEREAS: The Village understands the importance of this site as it relates to the future use and access to the Southern Seneca Lake shoreline; and

WHEREAS: The existing wastewater treatment plant site is a key Village asset and the Village seeks to maintain long-term ownership while maximizing the revenue potential of the property; and

WHERAS: Funds are available to support this project through the 2019 NYS Consolidated Funding Application; and

WHEREAS: The Village intends to use the investment, made through the bond issuance for the construction of the new regional waste water treatment plant as match for the grant funding;

WHEREAS: It is anticipated that the Watkins Glen Village Board, on behalf of the Village, will complete the necessary actions to authorize expenditures for the proposed project, accepting that they shall provide the match of the total of any grant funding awarded as a local match in the form of in-kind services or previous investment,

NOW THEREFORE, BE IT RESOLVED: That the Village of Watkins Glen Board of Trustees hereby authorizes and directs the Mayor to apply for funds through the Department of States 2019 Consolidated Fund and to further execute any additional documents or paperwork required to go along with said application.

Special Event Application - Italian American Festival (Aug. 9-11)

Trustee Nan Woodworth made the motion to approve the application. Trustee Anthony Fraboni seconded the motion. The Board then voted on the motion to approve and all were in favor. Motion Carried.

Special Event Application - Grand Prix Festival (Sept. 6)

Trustee Anthony Fraboni made the motion to approve the application. Trustee Laurie DeNardo seconded the motion. The Board then voted on the motion to approve and all were in favor. Motion Carried.

Special Event Application - Rally for Serenity (Sept. 14)
