VILLAGE OF WATKINS GLEN PLANNING BOARD 303 N Franklin Street Meeting of July 28, 2021

<u>Present:</u> Joe Fazzary, Jenna Tormey, Brian Eslinger, Deputy Clerk/Treasurer Barb Peterson and Code Enforcement Official (CEO) Darrin Stocum. Jim Adesso and Tom Fitzgerald were absent.

Chairman Joe Fazzary opened the meeting at 6:36 pm.

<u>Concept/Preliminary Plan Request:</u> Mark Lembeck (503 E Fourth Street) Fence

Mark Lembeck was present. CEO Stocum noted that building a fence in that zone would require a regular site plan approval. Chairman Fazzary indicated that the site plan would not be necessary as long as it complies with existing law, and suggested that a waiver could be invoked until the new zoning law is in effect.

Brian Eslinger moved to invoke 8.4 of the zoning law for 503 E Fourth Street. Jenna Tormey seconded and the motion passed unanimously.

Concept/Preliminary Plan Request: Village of Watkins Glen (Clute Park) Fence

CEO Stocum indicated the request for a fence was to help direct people safely around the park and to help protect the new foliage. Board concerns included Parks Director not present, barrier between people and the attraction, not enough input, unsure about Board of Trustees approval, relation to Master Plan objectives, submittal inadequate, and public awareness. Brian Eslinger moved to not approve the fence request for Clute Park and ask the head of the parks department to come to the next meeting to discuss. Jenna Tormey seconded. Discussion regarding the Lembeck motion and waiver ensued. No actual vote on the motion. Joe Fazzary moved to table this item until the Parks Director is available to come to the meeting with more information. Jenna Tormey seconded and the motion passed unanimously.

Brian Eslinger moved to have all applicants be present. Jenna Tormey seconded and the motion passed unanimously.

The minutes of June 23, 2021 incorrectly noted attendance. Brian Eslinger moved to table until the next meeting. Motion died for lack of a second.
