# Tree Removal Request

Trustee Laurie DeNardo made the motion to approve a request from Kurt Lodge at 210 6<sup>th</sup> Street to have 2 large locust trees in front of his house removed. They are dirty and beginning to damage his roof. Mr. Lodge would like to replace them with red maples. Deputy Mayor Louie Perazzini seconded the motion. The Board discussed the request and determined that there was not enough information provided to make a decision. The Board then voted on the motion and all were opposed. The matter was tabled to the next Board meeting. Motion Failed.

# **BOARD CONCERNS**

# Resignation – Parks & Recreation Coordinator

The Board accepted the resignation of Parks and Recreation Coordinator Diane Carl effective May 6, 2022.

# Outside/Sidewalk Dining (NYS Liquor Authority)

Deputy Mayor Louie Perazzini inquired about the outside/sidewalk dining regulations that were afforded during the pandemic, the law is no longer in effect. Businesses will need to obtain permitting from the New York State Liquor Authority if they choose to offer such a setting.

# Fat Daddy's Business

Trustee Laurie DeNardo questioned Sergeant-in-Charge Ethan Mosher about the operation of the "sticker" shop known as Fat Daddy's. He stated that he has been working with the Schuyler County District Attorney office, but at the present time they are operating legally.

# Office of the State Comptroller - Village Justice Corrective Action Plan

Trustee Laurie DeNardo asked about the response from the letter that was sent to former Justice Connie Fern Miller regarding the shortage of funds in the amount of \$421.00. A response was received from Connie Fern Miller stating that she didn't feel that she should be held liable. The Board did their due-diligence and it was decided to file all documents with the audit findings and not pursue any further at this time.

# Short-Term Rental Unresolved Code Violations

Trustee Nan Woodworth asked about the unresolved Short-Term Rental issues. Mayor Luke Leszyk stated they should have all resolved themselves with the new Zoning Law being that they are considered "existing/non-conforming" but will follow up with the Village attorney to be sure nothing more is required at this time.

Trustee Laurie DeNardo made the motion to exit public session and enter into executive session at 7:08 pm for a personnel matter involving the Code Department. Trustee Nan Woodworth seconded the motion. The Board then voted on the motion and all were in favor. Motion Carried.
