A. Village Ordinance #129 is hereby amended by the deletion of present subdivision "4" of Section 1 and the replacement thereof by a new subdivision "4" of Section 1 and also by the addition of a new Section 6 to said Ordinance. Said amended portions shall henceforth be as follows:

SECTION 1.

.....

(4) The cost for opening a grave shall be paid to the Village of Watkins Glen, New York before such work is done and such charge shall be \$100.00 for graves opened on Monday through Saturday and shall be \$125.00 for graves opened on Sunday or any national holiday.

SECTION 6. There shall be a \$25.00 charge for vault rental which shall be paid to the Village of Watkins Glen in advance.

B. Village Ordinance #147 shall be amended by deleting the present subdivision "c" of Section 12 and replacing it with a new subdivision "c" and by the addition of a new subdivision "d" of Section 12. Said amended portions shall henceforth be as follows:

12.

.....

c. It shall cost \$100.00 to open a grave from Monday through Saturday and \$125.00 to open a grave on Sunday or any national holiday.

d. There shall be a \$25.00 charge for vault rental which shall be paid to the Village of Watkins Glen in advance.

This local law shall take effect immediately upon filing with the Village Clerk, the Secretary of State and the State Comptroller as required by Section 27 of the Municipal Home Rule Law.
