A. Village Ordinance #129 is hereby amended by the deletion of present subdivision "4" of Section 1 and the replacement thereof by a new subdivision "4" of Section 1 and also by the addition of a new Section 6 to said Ordinance. Said amended portions shall henceforth be as follows:

SECTION 1.

- (4) The cost for opening a grave shall be paid to the Village of Watkins Glen, New York before such work is done and such charge shall be \$100.00 for graves opened on Monday through laturday and shall be \$125.00 for graves opened on Sunday or any national holiday.
- SECTION 6. There shall be a \$25.00 charge for vault rental which shall be paid to the 'illage of Watkins Glen in advance.
- B. Village Ordinance #147 shall be amended by deleting the present subdivision "c" of lection 12 and replacing it with a new subdivision "c" and by the addition of a new subdivision d" of Section 12. Said amended portions shall henceforth be as follows:

c. It shall cost \$100.00 to open a grave from Monday through Saturday and \$125.00
