The Traffic Regulation, Local Law No. 1 of the Village of Watkins Glen, is hereby amended by the addition of the following numbered subdivisions to Article X, Section 102 (a) prohibiting the parking of vehicles in the following designated locations:

19. On both sides of 10th Street between the north curb line of Magee Street and a point 20' westerly therefrom.
20. On both sides of 10th Street between the south curb line of Magee Street and a point 20' easterly therefrom.
21. Both sides of Magee Street between the north curb line of 10th Street and a point 30' northerly therefrom.
22. On both sides of Magee Street between the south curb line of 10th Street and a point 20' southerly therefrom.
