The Traffic Regulation, Local Law No. 1 of the Village of Watkins Glen, Article X, Section 104(b), prohibiting the stopping of any vehicles except buses, on the west side of Franklin Street in an area beginning 57 feet northerly from the north curb line of Fourth Street and continuing northerly for 50 feet to a point 107 feet northerly from the north curb line of Fourth Street, is hereby repealed.

This local law shall take effect immediately upon filing with the Secretary of State and upon approval of the New York State Department of Transportation.




