Pursuant to Section 6 of Chapter 602 of the Laws of 1993, as amended by a chapter of the laws of 1994, as proposed in legislative bill number S 8560-A, the Village of Watkins Glen hereby acts by local law, not subject to referendum, to provide that the collection of property taxes shall continue to be enforced pursuant to Title 3 of Article 14 of the Real Property Tax Law, as is in effect on December 31, 1994.

SECTION 2. Upon adoption, and no later than October 1, 1994, a copy of this local law shall be filed with the New York State Board of Equalization and Assessment.
