  - Section 2. Water rents shall be charged only to those properties at which there is water service available and a water meter connected to a structure on the property, and for a period of 90 days following the removal of water meter. In the event of removal of the water meter for a period in excess of 90 days, water rents shall cease to be charged for the subject property. Upon disconnection, removal of meter, or reconnection, a fee shall be charged to the property owner in an amount as from time-to-time determined by resolution of the Board of Trustees.
