Local Law No. 6 of 1997 is hereby repealed, returning the following described parcel of land to the R-2 District:

BEGINNING at the center point where S. Madison Ave. would intersect with Pine St. if extended in a straight line; thence northerly and northeasterly to and then along the centerline of S. Madison Ave. to the point of intersection with Steuben St.; thence northerly and northwesterly along the centerline of Steuben Street to the point of intersection with South Jackson St.; thence southerly and southeasterly along the centerline of S. Jackson St. to the intersection of S. Jackson St. with Pine St.; thence southeasterly along the centerline of Pine St. to the point or place of beginning, excluding a portion, westerly of Madison Ave., which is presently zoned B-1.

This Local Law shall take effect immediately upon filing with the Secretary of State.


