### PROFILE

The Village of Watkins Glen is located in as the county seat for Schuyler County the heart of the Finger Lakes and serves New York. The small upstate New York

village sits on the South shores of Seneca Lake, which is the largest of the glacial Finger Lakes.

The Police Department has a minimum of one officer on at a time, 24-hours a day, operating 365 days a year. The Police Department is staffed with 4 full time officers including a "Sergeant In Charge" and 3 full time officers. The Department is responsible for and provides 2 School Resource Officers to the Watkins Glen Central School District. The School Resource Officers work approximately 37.5 hours per week under the direct supervision of the Department. The Department also employs approximately 8 part time officers at any given time.



The Department has 3 marked patrol vehicles which are used for daily patrol, special

events, DWI enforcement and traffic details. One vehicle is also designated to the School Resource Officers when school is in session. The vehicles are traditional black and white with bold lettering of "Watkins Glen Police" as to be recognizable to the public and community for assistance.



The Department is taking a prioritized approach at community policing and becoming more approachable to the community members by actively using a social media page, implementing foot patrols, and leading community interaction events within the community. While focusing on the community policing side of law enforcement, the Department also takes an aggressive and proactive, yet empathetic approach to reducing crime, and promoting a safe and healthy community to visit and reside in.



## COMMUNITY DEMOGRAPHIC AND GEOGRAPHY

### **Geography**





Watkins Glen is located at the south shore of Seneca Lake, the deepest lake entirely within the state. Watkins Glen also hosts a beautiful State Park. The Watkins Glen State Park was opened to the public in 1863 and was privately run as a tourist resort until 1906, when it was purchased by New York State

According to the United States Census Bureau, the village has a total area of 2.2 square miles. 1.9 square miles of land and 0.4 square miles is water.

New York State Route 14 joins New York State Route 79 and New York State Route 414 by Watkins Glen. NY-14 is one of the principal streets in Watkins Glen village, also known as Franklin Street. New York State Route 329 and New York State Route 409 also lead into Watkins Glen from the west.

### **Community Demographic**

As of the census of 2019, the population of the Village of Watkins Glen was 2,000 people. As of the census of 2010, the racial makeup of the village was 96.2% White, 0.50% African American, 0.40% Native American, 0.50% Asian, 0.70% from other races, and 1.70% from two or more races. Hispanic or Latino of any race were 1.40% of the population.

There were (in 2010) 873 households, out of which 22.60% had children under the age of 18 living with them, 33.70% were married couples living together, 12.7% had a female householder with no husband present, and 49.40% were non-families. 42.40% of all households were made up of individuals. The average household size was 2.09 and the average family size was 2.86.

(2010) In the village, the age distribution of the population was spread out, with 22.70% under the age of 20, 5.40% from 20 to 24, and 31.80% from 25 to 50, \_\_% from 51 to 64, and 17.50% who were 65 years of age or older. The median age was 43.20 years old. The Village of Watkins Glen had 866 male residents, and 993 female residents.

The median income for a household in the village was \$34,969 and the median income for a family was \$55,357. Males had a median income of \$37,885 versus \$29,000 for females. The per capita income for the village was \$24,116. 5.0% of the population and 1.70% of families were living below the poverty line. 3.6% of those under the age of 18 and 6.80% of those 65 and older were living below the poverty line.

## WHAT IS EXECUTIVE ORDER #203?

### Police Reform and Reinvention Collaborative

<u>Background</u>: On June 12, 2020 Governor Cuomo signed Executive Order No. 203. The Executive Order states this was created in response to "...the police-involved death of George Floyd in Minnesota, protests have taken place daily throughout the nation and in communities across New York State in response to police-involved deaths and racially-biased law enforcement to demand change, action, and accountability."

On June 12, 2020, Governor Andrew Cuomo signed Executive Order (EO) 203, ordering all local governments that have police agencies to "perform a comprehensive review of current police force deployments, strategies, policies, procedures, and practices, and develop a plan to improve" them. The specific purposes for making changes are: "addressing the particular needs of the communities served by such police agency," promoting "community engagement to foster trust, fairness, and legitimacy," and addressing "any racial bias and disproportionate policing of communities of color." The order sets a deadline of April 1, 2021, for adoption of plans. On August 19th, the Governor announced a new Guidance concerning the collaborative groups being formed under EO 203. Among key stakeholders who "must be involved" is "the local public defender." Given the myriad of ways in which counties choose to provide public defense services under County Law § 722, this might be someone with an institutional provider or involved in an assigned counsel program.

# WATKINS GLEN POLICE DEPARTMENT'S RESPONSE TO EXECUTIVE ORDER 203

The Watkins Glen Police Department reviewed the executive order and began slowly implementing the order into the police department while making plans to complete a full reform project during the course of the year. In response to the order, some highlighted changes and developments occurred within the agency to include, new policy's, updated policy's, School Resource Officer reform project, survey developed for public to participate in, response to survey data and budget changes to better improve the agency. The survey was an excellent way for the stakeholders in the community to provide feedback, both positive and negative, with improvements to be made and point out positives within the department and community. Feedback immediately began coming into the department and changes and progression began immediately when information was obtained.



## COMMUNITY POLICING

As the police department moves forward with progression and reform, there are several changes the police department desires. The Watkins Glen Police Department will be moving forward with proposing to increase the department budget to allow for more staffing, which in return will allow for more time doing community policing. The police department also hopes to continue to host community events such as "SHOP WITH A COP" and "POPS WITH COPS". With the desired plan in place, the department will push to implement more than one officer on per shift during the busier months and weekends during the summer months specifically. Not only will this is allow for better service and safety to the community and its visitors, but this will allow for a more community involved approach to law enforcement. Having an officer on a foot/bike patrol will allow for more personal interactions with the community. This will allow officers to take the time to talk, visit and answer any questions or concerns the public might have. This will be very beneficial for the officers to educate the public on safety, crime, and how the department is run here locally.

## BIAS TRAING MOVING FORWARD

Members of the Watkins Glen Police Department shall not violate citizen's equal protection rights. To this end, members are prohibited from engaging in racial/bias policing in any aspect of law enforcement activity. All officers receive 8 hours of training in Cultural Diversity/Bias related incidents in the Police Academy. The Watkins Glen Police Department will also pursue annual bias training to be completed by all officers and a discussion to take place before and after the training.

# TARGETED PATROL AND THE BROKEN WINDOW THEORY

The broken windows theory is a criminological theory that states that visible signs of crime, anti-social behavior, and civil disorder create an urban environment that encourages further crime and disorder, including serious crimes. The theory suggests that policing methods that target minor crimes, such as vandalism, loitering, public drinking, jaywalking and regular traffic enforcement help to create an atmosphere of order and lawfulness, thereby preventing more serious crimes. The theory was introduced in a 1982 article by social scientists James Q. Wilson and George L. Kelling. The theory became subject to great debate both within the social sciences and the public sphere. Broken windows policing has become associated with controversial police practices, such as the "stop-and-frisk" policy by police commissioner William Bratton and Mayor Rudy Giuliani, whose policing policies were influenced by the theory. In response, Bratton and Kelling have written that broken windows policing should not be treated as "zero tolerance" or "zealotry", but as a method that requires "careful training, guidelines, and supervision" and a positive relationship with communities, thus linking it to community policing.

The Police Department also takes in to consideration public complaints on traffic patterns and possible illegal activity. We encourage the public to provide this information as often as possible. With this interaction with the community this helps in identifying and analyzing specific crime problems and locations and targeting resources toward solving those problems while in every day patrol or special details and patrol. We will continue to utilize this style of policing moving forward to aid in keep the community clean and safe for all.

# SCHOOL RESOURCE OFFICER REFORM PROGRAM

In the United States today there is a great need for a constructive and open dialog between law enforcement and the people this community serves and protects. There are thousands of police and law enforcement agencies in the United States, including federal agencies, state agencies, municipal and local agencies, and tribal agencies, to name a few. These agencies range in size from more than 30,000 sworn members, as in the case of the New York City Police Department, to only a handful of sworn officers, as in the case of the Watkins Glen Police Department. Each agency has its own unique set of circumstances and challenges. These are determined by many factors. These factors are as diverse as the communities and people served by these thousands of agencies.

It is impossible to assign a "One Size Fits All" approach to Police Reform, precisely because there are so many unique circumstances to consider in the American law enforcement landscape. However, some aspects of police reform are nearly universal. Certain truths are consistent across all agencies, and among all the people served and protected by law enforcement.

In the context of the School Resource Officer (SRO) Program of the Watkins Glen Police Department, several truths emerge:

### 1.) Increase Community Policing.

We will make it a goal to increase positive SRO interactions with the students and the community. In many jurisdictions across the country, Community Policing has emerged as successful strategic initiative for improving relations between law enforcement and the community. Community policing enhances safety within the community for both the resident/visitors and law enforcement officers. The Watkins Glen Central School is itself a community, and there is no reason why Community Policing will not enhance safety for students, staff, and SRO's, as it has in many communities across the country.

According to the national School Resource Officers Association, studies show that students coming from schools that have SRO's are less likely to be incarcerated both during the time they are in school and after they leave school. By increasing Community Policing by SRO's, we can help build a brighter future for our students. We can do this by increasing our positive interactions with students through increasing our attendance at school events as much as possible. In addition to increasing attendance at school sporting events, we will consider attending school plays, school concerts, school art exhibits, athletic practices, school fundraising events, and school clubs. By increasing our positive interactions with students, we build trust with our students and staff, we

enhance communication, and we improve public relations. Building trust is a hallmark of Community Policing and we should strive to do that at our school.

We can also enhance our community policing efforts by increasing SRO visibility in classrooms through guest lecturing and demonstrations in class. There are a number of faculty members who are interested in pursuing this and a number of students whose school experiences would be enhanced through these efforts.

We can also involve interested students and families in PBA activities through inviting students and families to join us at PBA events.

### 2.) Increase transparency.

Increasing transparency enhances the building of trust. There are many ways to increase transparency in the SRO program. For example, by entering more data into IMPACT about student interactions, we can expand the written record of day to day student interactions and activities of the SROs. While IMPACT is a law enforcement computer program that saves data permanently, entries into IMPACT do not have to be punitive in nature. Personal identifying information (PII) on students need not be entered into the IMPACT reports. A simple reference to a student's age or grade is all that is necessary to identify a student in an IMPACT report, for the purposes of data collection. This would serve to remove parental concerns about their child or children being mentioned in a police report and would increase trust with students and families.

Transparency will be further enhanced by increasing IMPACT data entry because the IMPACT database is subject to Freedom of Information Law (FOIL) access by parents and community members.

We can enhance transparency and build trust by making SRO personnel records available to the public upon request. In America there is a tremendous amount of trust that is placed in law enforcement personnel. Certainly the police who protect and serve our children are entrusted with a level of responsibility that is second to none. As SRO's we serve to protect some of the most vulnerable members of our community. Not only do we protect children as young as age four on a daily basis, but we also protect children with special emotional and physical needs every day. The SRO is responsible for the safety of our most precious resource: our children. The parents of our children deserve nothing less than full and complete, transparent access to the personnel records of School Resource Officers. By doing this we can help assure parents and the community that our officers can be trusted with the huge responsibility placed upon them.

We can further enhance transparency and trust by expanding body camera use to the SRO program. There are more than one hundred cameras in continuous use at the Watkins Glen Central School District, and their recordings are saved and searchable. They cover nearly all of the campus, but they do not operate inside the classrooms.

SROs should have body cameras available to them so they can be turned on in the event that an SRO experiences a situation with a student in an area not already covered by a school camera. The advantages to body camera use have been on display all over America for years now. Body camera footage helps people to understand what actually occurred in a given situation. While an SRO may make a detailed written report in which he or she articulates at length what happened in a situation, there is no substitute for body camera recordings. These recordings allow people who were not present at the scene to become a type of witness. When it comes to understanding what actually happened at a scene or in a situation, there is no substitute for actually being there, and body camera footage has emerged as the next best thing to actually being there. Body camera footage also enhances our understanding of what occurred at a scene because it does not forget and is not biased. Even people with very strong memories cannot remember all the details captured by a video recording and they routinely forget or fail to observe key details." The American people, by and large, understand that body camera footage allows for an unbiased and impartial view of an event that cannot be replicated by witness testimony or any other means. Our willingness to use body cameras as SROs demonstrates our willingness to have an impartial witness with us at all times.

### 3.) Improve training of SROs.

We can improve the quality of services provided by SROs by increasing training opportunities for them. Training in how to handle situations involving students and adults with mental or physical disabilities, will improve the quality of service we can provide to our students and school community. Students and parents with disabilities may present SRO's with unique challenges which call for unique responses. Our ability to better serve the school community will be enhanced if additional training in this respect is provided. This will enhance the safety of both the SROs and the people they approach.

We will increase training in de-escalation techniques. All across America, time and time again, de-escalation techniques have proven to be critical skills for the law enforcement officer to possess. Many lives have been saved and injuries avoided. SROs should be well versed and thoroughly trained in de-escalation techniques and training in this area should be increased and emphasized.

4.) Consider SRO attendance at trainings that addresses cultural awareness and fluency.

America is arguably the most diverse nation in the world. Our diversity can be a source of our greatest strengths. It can also lead to misunderstanding and friction. This can be reduced, if not eliminated, by increasing training in cultural awareness and improving cultural understanding.

It is impossible for any given individual to completely understand all cultures that differ from his or her own. However, by increasing our training that seeks to improve an SROs understanding of different cultures, we can improve our ability to be sensitive to considerations and challenges that might not be present in our own upbringings or cultures. By seeking to understand the viewpoint or perspective of someone from a different cultural background, we can avoid pitfalls that might come from miscommunication or misunderstanding of someone's intent. In a sense, cultural fluency can serve to improve the diplomacy often required by a law enforcement officer in his or her interactions with someone from a different culture. Diplomacy, understanding, and communication can mean the difference between a positive and negative outcome in a situation.





### Q1 Are you a Watkins Glen Village Resident?





## Q3 Please select the top five services that you think are the most important for the Watkins Glen Police Department to provide







# Q5 To what extent does the Village of Watkins Glen Police Department make it easy for community members to provide input [i.e. comments, suggestions, and concerns]?





## SOME CONCLUSIONS OF SURVEY RESULTS

In all, the community survey generated 95 responses. Of those 95 responses, 94 people answered the question in reference to being a village resident. It was determined 73.4% of respondents to that question were direct stakeholders in the community, being village residents.

Based on the survey results, 81.72% of people surveyed had contact with the Watkins Glen Police Department within the last 3 years.

Based on the results of the survey, it was determined the Watkins Glen Police Department should mainly be responsible in providing the following services;

- \*Investigations
- \*Routine patrol
- \*Respond to 911 calls
- \*Community policing
- \*Specials details (DWI enforcement, speed enforcement, seatbelt checks etc.)
- \*These 5 services were the highest selected out of 10 options. Providing School Resource Officers was a very close 6<sup>th</sup> in the survey.

53.19% of people surveyed "agree, or strongly agree" the Police Department could use more staffing to better serve the community, while only 21.27% of the results "disagree, or strongly disagree".

74.74% of people surveyed "agree, or strongly agree" the Watkins Glen Police Department should have more than one car on at a time during the busier months and weekends, while only 14.74% "disagree, or strongly disagree".

36.17% of responses from the survey determined the Police Department communicated "a little, or not all" with village residents. This shows there is significant room for improvement and will begin immediately.

70.79% of survey responses determine the Police Department needs more education, awareness and training.

77.17% of people surveyed believe the Watkins Glen Police Department should be utilized as a "closest car concept" to assist with emergency calls/complaints outside of the village. Specifically to preserve human life, protect property and assure officer safety.

19.15% of people surveyed believe the Watkins Glen Police Department "somewhat often, or very often" engages in racial profiling.

# RESPONSE TO SURVEY RESULTS AND MOVING FORWARD

In response to the reform survey and moving forward with police reform, the Watkins Glen Police Department is committed to progression in the community and improving police and community interactions while continuing to build trust between the public and police. The Watkins Glen Police Department understands that the world is forever evolving and it needs to adapt and identify those changes. While reform is needed across the country, there are major differences in regards to what shape that reform should take. The Watkins Glen Police Department requires a much different approach than say the NYPD or the Syracuse Police Department. Overall, police departments should excel in community oriented leadership and each agency should lead by example from the top down.

In some areas, reform will be similar, but when specifically discussing Watkins Glen, there are some obvious areas which can be improved according to the Reform Survey. The survey was necessary and will be used as a platform for the police department moving forward in day to day policing. The police department values community input and will continue to strive to keep law and order and community policing a priority. The Watkins Glen Police Department has proposed several budget adjustments for the 2021-2022 budget year. Some adjustments include, but are not limited to, increasing the budget for trainings and conferences; moving forward with implementing more than one officer on duty during our busier months and weekends; allowing lateral transfers to come to the department at a payment step based upon experience in an attempt to get more qualified candidates; and to begin a grant writing process to alleviate some financial burden on tax payers.

In the survey it was clearly outlined that community members believe the department needs more training. Training is a key factor in any situation to assure a safe and positive outcome for all involved. Some specific areas which will be addressed initially will be crisis intervention training and mental health awareness training. There is also a proposed budget increase for firearms training.

The survey also revealed that over 74% of the people who took the survey "agree, or strongly agree" the Watkins Glen Police Department should have more than one officer/car on duty during the busier months and weekends in our community. Not only will this allow the Watkins Glen Police Department to better serve the community and keep everyone safer, this will also allow other agencies such as the Schuyler County Sheriff's Department and New York State Police, to focus on other jurisdictions. This will allow for a safer and better served community outside of Watkins Glen. When scheduling permits, the police department will attempt to have two officers on duty during varying shifts on Thursday, Friday, Saturday and Sunday, during the months of May through the middle of October. This will allow for community interactions while having a foot patrol beat, and also at times give a more proactive approach to traffic enforcement and DWI enforcement.

# RESPONSE TO SURVEY RESULTS AND MOVING FORWARD-CONTINUED

The police department has implemented several new policies during the course of the reform project to include a body camera policy, NARCAN policy and an officer complaint policy to ensure transparency within the agency. The police department has also revised several policies during the reform project and will continue to do so moving forward.

The police department has implemented monthly meetings for all full time officers and school resource officers during the reform project as well. The material covered in these meetings includes, but is not limited to, public safety, officer safety, community interactions, drug houses and activity, school events and interactions, procedures and policy adjustments, in-house trainings, expectations of officers, new business within the agency, concerns from officers about safety or departmental issues, criminal activity in the community, and more. These meetings have helped in more ways than one in improving each officer's knowledge and education, camaraderie within the agency and more proactive efforts.

Some challenges the department hopes to overcome in the years ahead include keeping up with the higher demand of officers and the ever growing community of Watkins Glen. As the community and tourism continue to grow, the police department has drastically decreased over the recent years by about 33%. While the department has decreased, the call volume has remained the same or even increased. Moving forward, the department hopes to be restructured in years to come to better serve the community with a Chief, a Sergeant, a senior patrol/investigator and 3 full time officers.

The Watkins Glen Police Department will continue to analyze the results from the survey and gather all the data to move forward with progression and policing in our community. The survey will be referenced regularly when considering future staffing policies, training, and more. The Watkins Glen Police Department values the survey and all the input from the community.
