

# REGULAR MEETING OF THE BOARD OF TRUSTEES OF THE VILLAGE OF WATKINS GLEN HELD TUESDAY, MAY 16, 2023

## PLEDGE OF ALLEGIANCE

The public session of the meeting was called to order at 6:00 pm by Mayor Laurie DeNardo. Present were Mayor Laurie DeNardo, Deputy Mayor Peter G. Cherock, Trustee Nan Woodworth, Trustee Bob Carson, Trustee Margaret Schimizzi, Superintendent of Public Works Terry Wilcox, Clerk Fred Warrick and Treasurer Angela Ventra. Also present was Superintendent of Parks & Recreation Craig Bond, Code Enforcement Officer Scot Cole, Streets Supervisor Ken Barber, Water Supervisor Meghan Fox, Electric Supervisor Tom Ballard, and Sergeant-in-Charge Ethan Mosher. There were approximately five other persons in attendance.

## **PUBLIC HEARING**

Trustee Nan Woodworth made a motion to open the public hearing on the Zoning and Vendor laws. Trustee Margaret Schimizzi seconded the motion. The Board then voted on the motion and all were in favor. Motion Carried.

No one came forward to be heard on either law. The public hearing remained open until voting commenced.

## **Sewer Credit**

## **Zoning Law Amendment**

# Vendor Law Repeal and Replace

## Third Street as a Two-Way

Deputy Mayor Peter G. Cherock made the motion to renew and confirm that Third Street remains a two-way street until made permanent by pending revised street laws. Trustee Margaret Schimizzi seconded the motion. The Board then voted on the motion and all were in favor. Motion Carried.

## Adopted Budget for 2023-2024

Trustee Nan Woodworth made the motion to adopt the 2023 – 2024 fiscal year budget. Deputy Mayor Peter G. Cherock seconded the motion. In further discussion, Mayor Laurie DeNardo included that the budget is open to amendments as needed during the fiscal year. The Board then voted on the motion and all were in favor. Motion Carried.

## Sewer Credit

Trustee Bob Carson made the motion to approve the request for sewer credit for 228 N. Glen for \$20. Deputy Mayor Peter G. Cherock seconded the motion. The Board then voted on the motion and all were in favor. Motion Carried.

## **Mayoral Appointments**

Trustee Margaret Schimizzi made the motion to approve the mayoral appointment of Stacy Parish and Alan Benedict to the Zoning Board of Appeals. Trustee Bob Carson seconded the motion. The Board then voted on the motion and all were in favor. Motion Carried.

# LaFayette Park Rental Application

Deputy Mayor Peter G. Cherock made the motion to approve the revisions to the LaFayette Park Rental application to change the fee for non-profits to \$35.00, to include electricity at no additional charge. Trustee Margaret Schimizzi seconded the motion. Trustee Nan Woodworth abstained. The remaining Board then voted on the motion and all were in favor. Motion Carried.

Mayor Laurie DeNardo announced that rotted posts on the playground were discovered during the LaFayette project and repairs are being worked on. It is uncertain at this time how long before the playground reopens. Bathrooms are going in as part of the project and lights are also in the works.

# Corvette Festival – May 20<sup>th</sup> & 21<sup>st</sup> - Update

Superintendent of Parks and Recreation Craig Bond stated participation is now 189 cars between the two days. Police overtime to be paid through festival funds.

## Village Office Summer Hours
