

# **REGULAR MEETING OF THE BOARD OF TRUSTEES OF THE VILLAGE OF WATKINS GLEN HELD TUESDAY, MAY 21, 2024**

## PLEDGE OF ALLEGIANCE

The public session of the meeting was called to order at 6:00 pm by Deputy Mayor Peter G. Cherock. Present were Deputy Mayor Peter G. Cherock, Trustee Bob Carson, Trustee Margaret Schimizzi, Trustee Stephen Klemann and Clerk Fred Warrick. **WHEREAS**, situated on the Property is a modular home that has been damaged by fire and other hazardous debris, which poses an imminent threat to public safety; and

**WHEREAS**, the Owner and the Village deem it to be in the public interest, due to the environmental, health and safety risks, that the structure on the Property be demolished and any debris removed; and

**WHEREAS**, the Village with the assistance of the County of Schuyler in partnership through their shared services agreement has agreed to perform the necessary removal and demolition and such other services as the Village deems necessary to secure the Property.

**NOW, THEREFORE, BE IT RESOLVED**, Mayor Laurie DeNardo is hereby authorized to execute a Settlement Agreement and General Release for the Property to be demolished and removed.

Trustee Bob Carson seconded the motion. The Board then voted on the motion. All were in favor. Motion carried.
