

REGULAR MEETING OF THE BOARD OF TRUSTEES OF THE VILLAGE OF WATKINS GLEN HELD TUESDAY, FEBRUARY 4, 2025

PLEDGE OF ALLEGIANCE

The public session of the meeting was called to order at 5:00 pm by Mayor Laurie DeNardo. Present were Mayor Laurie DeNardo, Trustee Bob Carson, Trustee Margaret Schimizzi, Trustee Stephen Klemann and Clerk Fred Warrick. Also in attendance was Officer Anthony Agosto, Code Enforcement Officer Dennis Tremblay, and Superintendent of Village Parks & Recreation Stacey Parrish. Deputy Mayor Peter G. Cherock was absent. There was no one else in attendance.

ORDER TO REMEDY

No party appeared to contest the resolution by the Board of Trustees made on January 7, 2025 supporting the Code Enforcement Officer's findings dated January 2, 2025 to issue an Order to Repair or Remove the property located at 216 Lakeview Avenue.

MAYORAL APPOINTMENTS

Mayor Laurie DeNardo appointed Brian Eslinger to the Planning Board for a short term of one year to fill the position formerly held by Alex Gill, and David Lisk to the Zoning Board of Appeals to fill the position formerly held by Stacey Parrish. Trustee Margaret Schimizzi motioned to approve both appointments. Trustee Bob Carson seconded the motion. The Board then voted on the motion. All were in favor. Motion carried.

LOSAP

Trustee Stephen Klemann made a motion to adopt a resolution to approve the firefighter records listing for 2024.

WHEREAS, the Village of Watkins Glen has adopted a Length of Service Award Program (LOSAP) for the volunteer firefighters of the Watkins Glen Fire Department; and

WHEREAS, the LOSAP program requires that the Village of Watkins Glen Board of Trustees, as Program Sponsor, approve the firefighter records listing on an annual basis;

BE IT RESOLVED, that the Village of Watkins Glen Board of Trustees has reviewed and approved the attached firefighter records listing of all active members as it pertains to the Service Award Program for calendar year 2024.

Trustee Bob Carson seconded the motion. The Board then voted on the motion. All were in favor. Motion carried.

NYPA Power Rate Proposal

Trustee Stephen Klemann made a motion to adopt a resolution expressing opposition to the preference power rate proposal of the New York Power Authority.

WHEREAS, the New York Power Authority ("NYPA") has proposed a dramatic increase in the rates charged to its preference power customers as outlined in the December 2024 NYPA Preliminary Staff Report and pursuant to the Notice filed by NYPA under SAPA, the New York State Administrative Procedures Act, on December 31, 2024, and

WHEREAS, the Village of Watkins Glen Electric Department, a member of the Municipal Electric Utilities Association of New York State ("MEUA") and a preference power customer of NYPA, is entitled under federal law to be provided with electricity from the Niagara Power Project to be delivered by NYPA at the "lowest rates reasonably possible", and

WHEREAS, the MEUA has voiced its significant concerns with both the magnitude of these increases and the methodology used in their calculation, and

WHEREAS, the Board of Trustees of the Village of Watkins Glen Electric Department deems it likely

that NYPA's proposal to increase hydropower rates will have an adverse impact on our community, with particular risk to low-income residents and businesses already struggling economically to survive in an unfriendly New York State business environment.

NOW THEREFORE, IT IS HEREBY RESOLVED by the Board of Trustees of the Village of Watkins Glen Electric Department that NYPA is hereby requested and encouraged to re-examine the magnitude of its proposed rate increase, with particular emphasis on its requested profit percentage and its rapidly increasing administrative and general costs and its operation and maintenance expenses.

Trustee Margaret Schimizzi seconded the motion. The Board then voted on the motion. All were in favor. Motion carried.

PON 5737

Trustee Stephen Klemann made a motion to approve the New York State Energy Research and Development Authority agreement that supports the Village with technical assistance funding to develop grid modernization projects (PON 5737). Trustee Bob Carson seconded the motion. The Board then voted on the motion. All were in favor. Motion carried.

SmartKable Powerline Solutions, Inc.

Trustee Margaret Schimizzi made a motion to approve the service contract with SmartKable Powerline Solutions, Inc. to perform a full technical study on the Village's grid as part of the PON 5737 grant project. Trustee Bob Carson seconded the motion. The Board then voted on the motion. All were in favor. Motion carried.

Event Center Storage Shed

Trustee Margaret Schimizzi made a motion to approve the purchase of an 8' x 16' storage shed for the Event Center from Southern Tier Honda in the amount of \$4,747.65. Trustee Bob Carson seconded the motion. The Board then voted on the motion. All were in favor. Motion carried.

Seneca 7

Trustee Bob Carson made a motion approve the special event application for Seneca 7, April 27th, 10:30a – 2:30p. Trustee Stephen Klemann seconded the motion. The Board then voted on the motion. All were in favor. Motion carried.

Little Mania Wrestling

Trustee Bob Carson made a motion to approve the special event application for Little Mania Wrestling, May 31st, 7:30p – 9:30p. Trustee Margaret Schimizzi seconded the motion. In further discussion, the item was tabled.

Waterfront Festival

Trustee Margaret Schimizzi made a motion approve the special event application for the Waterfront Festival, June 14th, 11:00a – 7:00p. Trustee Bob Carson seconded the motion. The Board then voted on the motion. Mayor Laurie DeNardo recused herself as a chair on the board for the festival. All others were in favor. Motion carried.

Grand Prix

Trustee Stephen Klemann made a motion to approve the special event application for the Grand Prix Festival, September 4^{th} 10:00a-2:30p & 5th 9:00a-8:00p. Trustee Bob Carson seconded the motion. The Board then voted on the motion. Trustee Klemann recused himself for being on the board for the festival. All others were in favor. Motion carried.

Village Christmas

Trustee Bob Carson made a motion to approve the special event application for Village Christmas, December 5th, 5:00p - 8:00p. Trustee Stephen Klemann seconded the motion. The Board then voted on the motion. All were in favor. Motion carried.

Judicial Continuing Education

Trustee Stephen Klemann made a motion to approve Judge Steven Decker to attend the 2025 Continuing Judicial Education Core A and Core B Training, March 19th - 20th. No cost for the training, \$242.00 for two nights lodging. Trustee Margaret Schimizzi seconded the motion. The Board then voted on the motion. All were in favor. Motion carried.

2025 MEUA March Engineering and Accounting & Finance Workshops

Trustee Stephen Klemann made a motion to approve three electric employees to attend the 2025 MEUA March Engineering and Accounting & Finance Workshops, March 18th & 19th at a rate of \$169 per person. Trustee Bob Carson seconded the motion. In further discussion, the clerk requested sending the Treasurer. The motioned was amended to add Naomi Kinglsey. The Board then voted on the motion. All were in favor. Motion carried.

Property/Evidence Room Management

Trustee Margaret Schimizzi made a motion to approve officers Aaron Jumper and Christoper Daloia to attend a free property/evidence room management training, February 4th & 5th. Lodging \$125. Trustee Stephen Klemann seconded the motion. The Board then voted on the motion. All were in favor. Motion carried.

American Public Association's 2024 Structures Project of the Year Award

Trustee Stephen Klemann made a motion to approve Mayor Laurie DeNardo's attendance to the American Public Works Association annual award ceremony on February 13th to receive a 2024 Structures Project of the Year Award for the Downtown Revitalization Initiative project.
